- Most of the natural gas and oil shale is located on public lands across the western U.S., and leasing of these lands must strike a careful balance between drilling efficiency and environmental awareness.
- NIMBY issues − Not In My Backyard − are ever more a hot button in energy development. Siting of plants, transmission facilities, and hydraulic fracturing will become more arduous and complex.
