# Canadian Companies as US Importers of Record Have You Assessed Your US Import Activity?

Many Canadian companies serve as non-resident importers of record for their US bound shipments. As such, they are required to be compliant with US Customs and Border Protection (CBP) laws and other import regulations as if they were US-resident companies. Arent Fox LLP has found that our Canadian clients realize the need to have accurate or current data on their US import compliance performance in order to gain a good sense regarding their exposure to possible Customs enforcement actions and other fiscal risk exposure.

In a nutshell, as the US marketplace grows more complex and as more imports from third countries arrive at US ports of entry, Canadian companies will want to keep their competitive edge by being smarter and best prepared for the years ahead.

We believe that a very useful starting point – and as a helpful tool to perform periodic internal checks – is to obtain information from CBP regarding the company's import activity for a certain period of time, usually the last five years. With a company's authorization, we can obtain on their behalf this information, known as the Importer Trade Activity (or ITRAC) database, from CBP HQ here in Washington, DC. This information is essentially a "snapshot" of the company's US import operations proprietary to that company. CBP uses this information in support of its compliance and enforcement efforts, including the scheduling of audits, requesting information on entries, and the assessment of fines and penalties.

What you get – This exercise is a snapshot of a company's import transactions from the eyes of CBP. The analysis Arent Fox provides would include identification of potential high risk areas, recommendation of opportunities for duty savings, a description of your company's import trends, and an analysis your service provider relationships, such as Customs brokers.
